### **ADVOCATING FOR TTIP FUNDING**

The following letter is an example of the ongoing lobbying effort to support retention of categorical status for TTIP which was sent to members of the Senate budget committee and to Chancellor Drummond on behalf of three statewide organizations: CCL, CISOA, and LLARC.

March 17, 2004

We are writing to you to express our serious concern with a portion of the FY 2005 Community College system budget proposal. Specifically, we are referring to the proposed change in the allocation method for Telecommunications and Technology Infrastructure Program (TTIP) funds. Funding through the TTIP program provides colleges with essential Internet services and support for other critical digital resources. The boards of directors of our three organizations unanimously object to moving a majority of these funds into general apportionment allocations.

Since its inception, TTIP has been an overwhelmingly successful program. Few state initiatives in the last decade have produced more positive results than TTIP. The program has brought *all* of California's community college students a level of technological access that could not have been achieved by colleges acting alone. A wise man with bad grammar once said "If it ain't broke, don't fix it." We believe this philosophy clearly applies to the TTIP funding allocation method.

TTIP has become the technological lifeblood of small colleges. Generally speaking, small colleges are rural and remote. With few exceptions, the cost to provide Internet connectivity to small colleges is dramatically higher than large urban campuses. In a general apportionment funding model, small colleges would receive fewer dollars to support the cost of their Internet connectivity. Similarly, small colleges would receive fewer dollars to support the electronic resource collections of their libraries. If these funds become part of general apportionment, libraries could end up with no funds at all for electronic collections. This would result in students at these colleges losing access to electronic resources.

Moving the dollars previously dedicated to support networking and library electronic resources into general apportionment funding virtually eliminates the system's ability to take advantages of economies of scale. When negotiating for telecommunication services and electronic resource licenses as a system of 108 colleges we possess tremendous clout that results in lower cost and higher quality of service for all colleges. We are confident no college or district, regardless of size, can negotiate more favorable terms for Internet connectivity or library electronic resources than Chancellor's Office and other California community college-based organizations acting on behalf of the entire system.

Given the economic diversity of our state, it should surprise no one that there exists a digital divide among California's community college students. Moving more than \$12 million dollars from the TTIP categorical allocation into general apportionment funding will serve to accomplish only one thing – the substantial widening of the gap between the technology "haves" and "have-nots" in California's community colleges. We strongly urge you and your colleagues in the legislature to support a budget proposal for the allocation of TTIP funds on a categorical basis consistent with the history of the program.
